NOTICE OF LOCATION -- LODE CLAIM

600 feet S72°30'W to NE corner #2, which is a Axle Post,
thence 750 feet S17°30'W to the E side center, a Rail Tie,
thence 250 feet S17°30'W to SE corner #3, a Axle Post,
thence 600 feet N72°30'W to SW corner #4, a Axle Post,
thence 750 feet N17°30'E to the W side center, a Rail Tie,
thence 250 feet N17°30'E to Corner #1, the point of beginning.
