

AMENDED CERTIFICATE

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Willow Creek #206 Lode Mining Claim in Section 21, Township 1N, Range 57E in the Freiberg Mining District, in Lincoln County, in the State of Nevada, on the 4 day of December, 19 80.

The claim is 1500 feet long and 600 feet wide, and 10 feet is claimed in a westerly direction and 1490 feet in a easterly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the northerly to the southerly.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by lumber pencil.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
