CERTIFICATE OF LOCATION

To tie this claim to the Public Survey, begin at the NE/cor. of Section 25 within 1 North, Township 1 North, Range 66 East, Mount Diablo Meridian, thence,

4200' South and 10,560' West to the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 10 feet from the location monument in a Easterly direction, and 1490 feet in a Westerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NW Corner of the BPX # 63 Claim;" the southwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SW Corner of the BPX # 63 Claim;" the southeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SE Corner of the BPX # 63 Claim;" the northeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NE Corner of the BPX # 63 Claim." There is also a wood post 4"x4"x4 1/2' at the center of each side line.

The monumentation and marking of the corners was completed by the 24th day of March, 1981.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$18.00 lode claim filing fee has been paid to the County Recorder.
