GRANT, et al., vs. SMILE DEED

This Indenture Witnesseth: That the Housing Authority of the County of Lincoln, Nevada, Party of the first part in consideration of \$1.00 (One), the receipt of which is hereby acknowledged, do hereby Grant, Bargain, Sell and Convey to Carefree Living, a Limited Partnership, Organized Under the Laws of the State of Nevada, Party of the Second Part, all that real property situate in the Town of Pioche, County of Lincoln, State of Nevada, bounded and described as follows:

A parcel of land situate in Sections 15 and 2, T. L.N., R. 67E., N.D.S. & C., Lincoln County, Nevada and further described as follows:

Beginning at a point (1) from which the Southwest Corner of Section 15 bears N. 88° 00' W. 4118.99 feet, more or less; thence N. 30° 48' 15" E. 305.02 feet (2); thence Northeasterly 57.50 feet, more or less along existing curb (3); thence N. 34° 11' 56" E. 196.65 feet (4); thence S. 58° 56' E. 271.17 feet (5); thence S. 31° 04' W. 65.60 feet (6); thence N. 58° 56' W. 89.48 feet (7); and thence S. 31° 04' W. 536.69 feet, more or less to the point of beginning.
