INTRODUCTION

The Don Dale Property is located approximately six miles south of Rachel, Nevada at the north end of the Groom Range.

The reason for this examination was to determine if the surface geology was indicative of a porphyry molybdenum system and deposit at depth.

Five man days were spent in the field examination and two days in the office compiling the geology and examining surface rock samples collected.

The cost of the examination is in excess of \$1,300.00 and will be used for the assessment work for the assessment year ending September 1, 1981.

LOCATION

The Don Dale Property is located approximately twelve miles southwest of the Tempiute Mine and thirty-six miles in an airline northwest of Alamo, Nevada.

PROPERTY

The property consists of thirteen unpatented lode claims located in Sections 34 and 35, Township 4 South, Range 55 East. The claims are in the Don Dale mining district. They are partially surrounded on the north by AMAX's Michelle Claims.

The Don Dale property is owned by Mr. Farrell Anhder and Mr. Clarence G. Edwards, 106 Elm Street, Henderson, Nevada. The property is under lease to Gray-hill Exploration Company, 12189 Relaton Road, Suite 210, Arvada, Colorado.

HISTORY AND PRODUCTION

According to Tschanz, 1970, the Don Dale district was organized in 1945, and the total production was probably less than 200 tons. Smelter records furnished by the owners, show that approximately eighty-five tons were shipped to American Smelting and Refining Company in Salt Lake City between 1938 and 1941. The average grade of the ore shipped was approximately 0.058 ounces gold, 31.2 ounces silver, 14.3 percent lead, 0.28 percent copper and 0.67 percent zinc.

In April, 1981, Grayhill Exploration Company leased the property. Geological mapping and limited geochemical sampling were done on the property in February and July of 1981.

CEOLOGY AND GEOCHEMISTRY

Geologic mapping was done on an aerial photographic base at a scale of 1:25,000. The mapping outlined numerous dikes and plugs both on the Don Dale Claims and adjacent to them. The intrusive rocks cut primarily Cambrian quartzite.

Several select rock samples were taken of the dikes for petrographic examination and geochemical analysis.

The geologic map showing the sample locations is attached to this report.

The dikes vary in composition from quartz eye, latite porphyry to possible rhyolite. The main intrusion mass is a finer grained latite. The dikes are often hydrothermally altered and geochemically anomalous in copper, lead and sinc.

This detailed report is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the Blue Bird, Blue Bird 2 through 4, and Jackson, Jackson 2 through 5 lode mining claims situated in the Don Dale Mining District, Lincoln County, Nevada.
