# CERTIFICATE OF LOCATION

We (or I) claim 1200 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 600 feet from the location monument in a N 70° W direction, and 600 feet in a S 70° E direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner of the KLSS No 3 Claim;" the southwest corner is marked by a 4x4 Post 4' feet high, inscribed "SW Corner of the KLSS No 3 Claim;" the southeast corner is marked by a 4x4 Post 4' feet high, inscribed "SE Corner of the KLSS No 3 Claim;" the northeast corner is marked by a 4x4 Post 4' feet high, inscribed "NE Corner of the KLSS No 3 Claim." There is also a 4x4 Post at the center of each side line.

The monumentation and marking of the corners was completed by the 10 day of July, 1981  
(must be within 90 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
