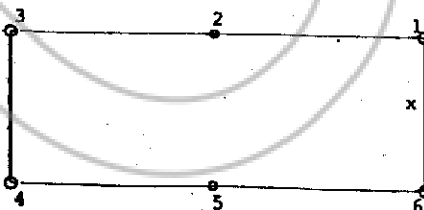

KNOW ALL MEN BY THESE PRESENTS, That Hunt Oil Company of Nevada, Minerals Division, has this 9th day of January, 1982, located and claimed, and by these presents does locate and claim, by right of discovery and location, in compliance with the Mining Acts of Congress, approved May 10, 1872, and all subsequent acts, and with local customs, laws and regulations, 1500 linear feet and horizontal measurement on the BL # 13 lode, vein ledge or deposit, along with the vein thereof, with all its dips, angles and variations, as allowed by law, together with 300 feet on the North side, and 300 feet on the South side of the middle of said vein, at the surface, so far as can be determined from present developments, and all veins, lodes, ledges or deposits and surface ground within the lines of said claim 1480 feet running W from the point of discovery monument and 20 feet running E from the point of discovery monument; said discovery monument being situate upon said lode, vein, ledge or deposit, and within the lines of said claim, in Undesignated Mining District, County of Lincoln and State of Nevada described by metes and bounds as follows, to-wit: Beginning at Corner No. 1, the Northeast corner which is located 2,100 feet S and 13,200 feet E from the NW corner of Section 21 Township 6S, Range 64E, Mount Diablo Meridian, thence 750 feet West to the North side center; thence 750 feet West to the Northwest corner; thence 600 feet South to the Southwest corner; thence 750 feet East to the South side center; thence 750 feet East to the Southeast corner; thence 600 feet North to the point of beginning.

1. Legal Subdivision of the land upon which the claim is located, if such land is surveyed: NW Quarter of Section 23 Township 6S Range 64E of the Mount Diablo Meridian, in the County of Lincoln, State of Nevada
2. The monuments recited herein are 4" x 4" x 4 1/2" wood posts of native lumber and marked with metal tags identifying claim corners and side centers.
3. A map complying with NRS 517.040 has been prepared and will be filed in accordance with statutes.
