AMENDED DECREE OF DIVORCE

The above entitled matter having come on regularly for trial on the 19th day of February, 1982, with Plaintiff appearing in person and through her attorney, GERALD W. HARDCASTLE, ESQUIRE, and with Defendant appearing in person and through his attorney, GEORGE D. FRAME, ESQUIRE; the Court having heard the testimony of witnesses sworn, considered exhibits introduced at trial, and heard the arguments of counsel in open Court; the matter having been submitted for decision and the parties hereto by separate Stipulation having waived Findings of Fact, Conclusions of Law, and written Notice of Entry of Judgment, and the Court being fully advised, FINDS:

That the Court has complete jurisdiction in the premises, both as to the subject matter thereof as well as the parties thereto; that the Plaintiff now is, and has been an actual bona fide resident and domiciliary of the County of Lincoln, State of Nevada, and has actually been domiciled therein for more than six weeks immediately preceding the commencement of this action; that all of the allegations contained in Defendant's Counterclaim for divorce

are true as therein alleged and that Defendant/Counterclaimant is entitled to a Decree of Divorce from Plaintiff/Counterdefendant on the grounds set forth in Defendant's Counterclaim; that the Property Settlement Agreement of the parties dated August 26, 1969, is valid and should be approved by the Court; and that the property distribution under the Property Settlement Agreement should be confirmed and ratified by the Court but not merged into the Decree of Divorce.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the bonds of matrimony heretofore and now existing between Plaintiff and Defendant be, and the same are hereby wholly dissolved and an absolute decree of divorce is hereby granted to Defendant/Counterclaimant, L. B. KEITH, and each of the parties hereto is hereby restored to the status of a single, unmarried person; and it is
