ASSIGNMENT OF OVERRIDING ROYALTY

Assignors hereby warrant unto Assignee and its successors and assigns that Assignors have received assignments of the

overriding royalties from their immediate predecessors in interest and have filed such assignments for record and that the overriding royalties hereby assigned are free and clear of all liens, encumbrances, burdens, and defects of title arising by, through, or under Assignors, but not otherwise, and that Assignors shall warrant and forever defend the title of Assignee and its successors and assigns against any and all persons claiming or attempting to claim an interest in the overriding royalties hereby assigned by, through, or under Assignors, but not otherwise.

The references herein to liens, encumbrances, burdens, defects, and other matters are for the purpose of defining the nature and extent of Assignors' warranty and shall not be deemed to ratify or create any rights in third parties.

Except as stated herein, Assignors do not make any other warranty, express or implied.
