

DEED

THIS INDENTURE, made the 3rd day of May, 1982, between KEITH M. WHIPPLE and GWENDOLYN WHIPPLE, Husband and Wife parties of the first part and hereinafter referred to as "Grantors", and EDWARD W. ~~MALLOY~~ ^{MALLOY} and CATHY T. ~~MALLOY~~ ^{MALLOY}, Husband and Wife parties of the second part and hereinafter referred to as "Grantees";

WITNESSETH:

That the said parties of the first part, for and in consideration of the sum of One Dollar (\$1.00), lawful money of the United States of America, and other good and valuable considerations, the receipt whereof is hereby acknowledged, do hereby grant, bargain and sell unto the said parties of the second part, in joint tenancy and to the survivor of them and to the heirs of such survivor forever, all that certain lot, piece or parcel of land situate, lying and being in the County of Lincoln, State of Nevada, and bounded and particularly described as follows, to-wit:

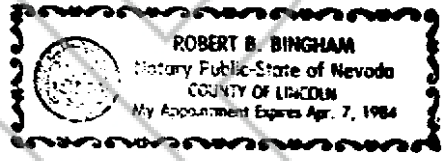
