

If any parama lightle to pay any tax neglects or returne to pay the same after demand, the amount (including any lateness, additional amount, addition to tax, or expressable penelty, together with any costs that may accrue in addition thereto) shall be a less in taxor of the United States upon all property and rights to preparty, whether real or personal, belonging to such person.
