

# Certificate of Location of Lode Claim

- the SOUTHWEST corner is marked by a 4" DIAM PVC PIPE 4 feet high, inscribed THE # 11 corner PEP 17 mining claim;
- the SOUTHEAST corner is marked by a 4" DIAM PVC PIPE 4 feet high, inscribed THE # 2 corner PEP 17 mining claim.
