

JOINT TENANCY DEED

THIS INDENTURE made this 5th day of October A.D. 1982, between husband and wife Donald J. Harrington and Sue M. Harrington, the party of the first part, and Donald J. Harrington and Sue M. Harrington, husband as joint tenants with right of survivorship, the parties of the second part,

WITNESSETH: That the said party of the first part in consideration of the

sum of ten dollars (\$10.00), lawful money of the United States of America, and other and further valuable consideration to be paid by the parties of the second part, the receipt whereof is hereby acknowledged, do by these presents, GRANT, BARGAIN and SELL unto the said parties of the second part, as Joint Tenants and not as Tenants in Common, and to the survivor of them and the heirs and assigns of such survivor forever, all that certain lot, piece, or parcel of land situate in the tenant Dry Valley County of Lincoln, State of Nevada, and bounded and described as follows:

A Parcel of land situated in the SW2 of the NE%, Section 31, Township 1 North, Range 69 East, M.D.B. & M., being more particularly described as follows:

Beginning at the North Point (1) from which the North Quarter Corner of said Section 31, bears N 19° 19' W a distance of 1620.2 feet more or less, thence S 45° E a distance of 256.5 feet more or less, to the East Corner (2); thence S 45° W a distance of 509.5 feet more or less, to South Corner (3); thence N 45° W a distance of 256.5 feet more or less to the West Corner (4); thence N 45° E a distance of 509.5 feet more or less to the point of beginning.

Said parcel contains 3.0 acres, more or less.
