CORRECTED DRED

THIS INDENTURE, made October 9th, 1978, by and between William U. Schofield, Trustee of the William U. Schofield Trust, of Hiko, in the County of Lincoln, State of Nevada, party of the first part, hereinafter called the Grantor, and William R. Mackintosh and Maria Mackintosh, of the same place, parties of the second part, hereinafter called Grantees, WITNESSETH:

That the Grantor, for and in consideration of the sum of Forty Dollars (\$40.00), lawful money of the United States of America, receipt whereof is hereby acknowledged, do by these presents grant, bargain and sell, convey and confirm unto the Grantees, and to their heirs and assigns forever, all of the right, title and interest of the Grantor in and to all of the following parcel of land, situated in Pahrangat Valley near Hiko, in the County of Lincoln, State of Nevada, specifically described as follows:

Beginning at a point 577.5 feet south of the NW corner of the NW 1/4 of the NE 1/4 of the NE 1/4 of Section 34, Township 4 south, range 60 East N.D.B. and M. and running east parallel to the north line thereof, a distance of 415.5 feet, thence south 212 feet, thence west 415.5 feet thence north 212 feet to point of beginning, containing 2.02 acres together with the right for culinary use of water from one water well located in the above mentioned portion of Section 34.

TO HAVE AND TO HOLD the above described premises, unto the said Grantees and their heirs, and assigns forever. And the said Grantor and his heirs, the said premises, in the quiet and peaceable possession of the said Grantees, their heirs and assigns against the Grantor and his heirs and against all and every person and persons whomsoever lawfully claiming or to claim the same, shall and will warrant and by these presents forever defend.

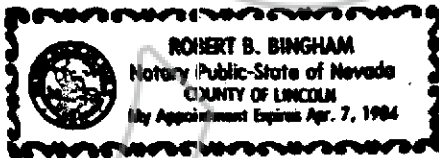
