W I T N E S S E T H:

That the parties of the first part, in consideration of the sum of Ten Dollars (\$10.00), lawful money of the United States of America, to them in hand paid by the party of the second part, and other good and valuable considerations, the receipt whereof is hereby acknowledged, does by these presents remise, release, and forever QUITCLAIM unto the party of the second part and to her heirs and assigns all of those certain lots, pieces and parcels of land situate in the County of Lincoln, State of Nevada, and bounded and particularly described as follows, to-wit:

Parcel No. 1: A parcel of land, situated in the NE $\frac{1}{4}$ of Section 2, T3S., R67E., MDB& M., bounded and described as follows:

Beginning at the NW corner of the NE $\frac{1}{4}$ of said Section 2, and running thence due east 1660 feet, thence S. 27° 02' East 1120 feet, thence due West 1155 feet thence due North 990 feet to the place of beginning, excepting and reserving therefrom right of way for Highway 93.

Parcel No. 2: A strip of land across the southerly portion of part of the SE $\frac{1}{4}$ of Section 35, T2S., R67E., MDB&M., bounded and described as follows:

Beginning at the SW corner of the said SE $\frac{1}{4}$ of Section 35, and running thence North 31 feet, thence Southeasterly to the West boundry line of the Union Pacific Railroad (Caliente-Pioche Branch) right of way, thence southerly along said right of way a distance of 6 feet to the Section line common to Section 35, T2S., R67E., and Section 2, T3S., R67E., thence west along said Section line to the point of beginning, and being the same strip of land acquired by Grantor herein from Thomas L. 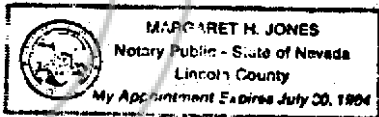

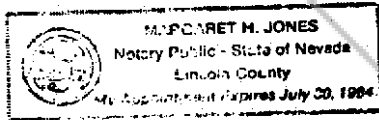
