Gentlemen:

Pursuant to the provisions of 43 U.S.C. § 1744(a) and 43 C.F.R. § 3833.2-3, the undersigned Houston International Minerals Corporation (the "owner"), whose address is P. O. Box 10200, 3801 E. Florida, Denver, Colorado 80210, hereby gives this notice of intention to hold the mining claim(s) more particularly described in Exhibit A attached hereto and incorporated by reference herein.

In compliance with the above-cited law and regulations, the owner(s) hereby set(s) forth the following information:

(a) The serial number assigned to each claim by the authorized officer upon filing in the proper B.L.M. office of a copy of the notice or certificate of location is set forth opposite the name of each such claim in Exhibit A. 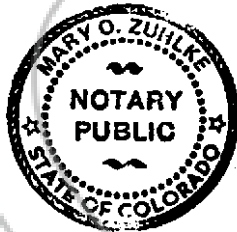
