All of Lots 15, 16, and 17, Block 31, Pioche, Nevada Together with all improvements, privileges and appurtenances.

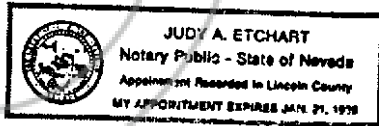
