DECLARATION OF HOMESTEAD

1 KNOW ALL MEN BY THESE PRESENTS that we, Larry R. Wilkinson and  
 2 Sara Ann Wilkinson, are husband and wife; that we are, at the  
 3 time of making this declaration, actually residing on the  
 4 premises hereinafter described and we claim said premises as  
 5 homestead, as Joint Tenants.  
 6 The premises so claimed by us are situated in the Lincoln county,  
 7 State of Nevada, described as follows, to wit;

8 Beginning at the northwest corner of the NE1/4SW4 of Section  
 9 35, T. 2N., R. 69 E., MDB&M, thence running East 1600 feet,  
 10 thence running South 5° 15' West a distance of 521 feet to  
 11 the True point of beginning, thence continuing South 5° 15'  
 12 West a distance of 235 feet to the Southeast corner of this  
 13 tract, thence running North 73° 55' West a distance of 264  
 14 feet to the East right of way line of the County Road,  
 15 thence running North 17° 10' East along the east right of  
 16 way line of the county road a distance of 235 feet, to  
 17 the Northwest corner of this tract, thence running Due East  
 18 a distance of 227 feet more or less to the true point of  
 19 beginning, and being all situate in the NW1/4SE1/4 of Section  
 20 35, T2N., R69E., MDB&M. EXCEPTING therefrom an easement  
 21 for the present road through this property.

 23 hereto belonging or in anywise appertaining, and the reversions,  
 24 remainders, rents, issues and profits thereof.

 26 with the appurtenances unto the said parties of the second part,  
 27 and to their heirs, successors and assigns forever.
