### DECLARATION OF HOMESTEAD

(BY WIFE OR HUSBAND WITHOUT JOINDER OF SPOUSE)

- (6) The character of said property so sought to be homesteaded, and the improvements thereon, may generally be described as follows:

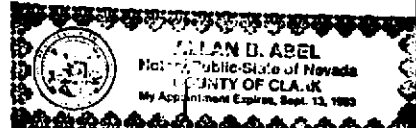
