

# Certificate of Location of Lode Mining Claim

The general course of the lode deposit and premises is from the East Side to the West Side.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by A piece of paper in a small bottle nailed to a post

- Corner No. 6 is a Tree Cut Approx 5' in height Limbed + Blazed

The monumentation and marking of the corners was completed by the 15 day of January, 19 83.
