10 JUDGMENT AND DECREE OF DIVORCE

11 THIS CAUSE coming on regularly this day to be heard before the
12 Court sitting without a Jury upon the verified complaint of the
13 plaintiff and all the records and files in this case; said plain-
14 tiff appearing in person and by and through her attorney, James L.
15 Wadsworth, and the defendant not being present in person, but hav-
16 ing heretofore caused to be filed his duly acknowledged Answer, in
17 propria persona, authorizing the Court to proceed with the hearing
18 of this action without further delay or notice and the case being
19 at issue.

22 WHEREUPON evidence having been produced by plaintiff herein in sup-
23 port of the allegations contained in her complaint, from which it
24 satisfactorily appears and the Court finds that all of the said al-
25 legations are true and plaintiff's residence and good faith thereof
26 having been proved and corroborated as required by law and the Court
27 being fully advised as to the law and facts in the premises;

29 IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

30 1.

32 That the bonds of matrimony now and heretofore existing between

1 the plaintiff, ELLEN JOAN EYRAUD, and defendant, RAYMOND L. EYRAUD,
2 be, and the same are hereby, wholly dissolved and held for naught,
3 and said plaintiff is hereby awarded an absolute and final Decree
4 of Divorce from said defendant upon the ground of great and extreme
5 cruelty, as that term is defined by the laws of the State of Nev-
6 ada, without just cause therefor.
7

8 2.

9 That the care, custody and control of the minor children of the
10 parties hereto, to-wit: John Raymond, aged 18, and Cheryl, aged 11,
11 be, and the same are hereby, awarded to plaintiff.
12

13 That defendant is ordered to pay to said plaintiff for the support
14 and maintenance of the said minor children of the parties Fifty
15 Dollars (\$50.00) per month per child, subject to the terms of the
16 Separation Agreement dated November 12, 1966; that the first of
17 said payments is to be made on or before the 1 day of Dec
18 1966, and the subsequent payments shall be made on or before the
19 1 day of each calendar month thereafter, said payments to con-
20 tinue until the particular child has reached the age of majority
21 or has otherwise become self-supporting;

24 That defendant is entitled to have the right to visit said minor
25 children at any and all reasonable times and places under reasonable
26 circumstances so long as he is current in the payment of child
27 support, but not otherwise.

29 3.

30 That that certain "Separation Agreement" entered into on November
31 12, 1966, determining and settling certain rights as between the
32 parties hereto, and which said Agreement also provided for the

1 settlement of the community property of the parties, and which
2 said Agreement was filed herein, shall be, and the same is hereby,
3 adopted and ratified by the Court, and by such reference is in-
4 corporated into this Decree of Divorce with the same force and ef-
5 fect as if the same were written out in detail herein.

7 4.

8 The Court reserves jurisdiction over the parties hereto and over
9 the minor children of said parties to make such other and further
10 orders with respect to the care, custody, support and maintenance
11 of said minor children as shall from time to time seem meet and
12 proper in the premises.
