That the care, custody and control of the minor children of the parties hereto, to-wit: John Raymond, aged 18, and Cheryl, aged 11 be, and the same are hereby, awarded to plaintiff.

That defendant is ordered to pay to said plaintiff for the support and maintenance of the said minor children of the parties Fifty bollars (\$50.00) per month per child, subject to the terms of the Separation Agreement dated November 1 1966; that the first of said payments is tobe made on or before the day of 1966, and the subsequent payments shall be made on or before the day of each calendar month thereafter, said payments to continue until the particular child has reached the age of majority or has otherwise become self-supporting;
