

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The claim is 1500 feet long and 600 feet wide, and 1400 feet is claimed in a N70°W direction and 100 feet in a S70°E direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by lettering that states which corner or side center is the monument

- Corner No. 4 is a Cedar Post 5' marked NE corner Doyle 14
- Corner No. 5 is a Blazed Tree marked S side center Doyle 14
- Corner No. 6 is a Blazed Tree marked SW side center Doyle 14

The monumentation and marking of the corners was completed by the 16th day of March, 1983

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
