

MINING DEED

KNOW ALL MEN BY THESE PRESENTS that RESCO INTERNATIONAL, INC., a Nevada corporation ("Grantor"), in consideration of Ten Dollars (\$10) and other good and valuable consideration, hereby grants, bargains, releases and conveys to MERC MINERALS COMPANY, an Oregon corporation ("Grantee"), those certain unpatented mining claims described in Exhibit A attached hereto and incorporated herein by reference.

TOGETHER WITH all dips, spurs and angles, and also all the minerals, metals, ores, gold and silver-bearing quartz, rock and earth and all other minerals therein; and all the rights privileges and franchises thereto incident, appendent and appurtenant, or therewith usually had and enjoyed; and also, all and singular, the tenements, hereditaments, and appurtenances thereunto belonging, or anyway appertaining, the rents, issues and profits thereof; and also the estate, right, title, interest, property, possession, claim and demand whatsoever in law and in equity of said Grantor to said unpatented mining claims.

TO HAVE AND TO HOLD the above-granted unpatented mining claims, with all the privileges and appurtenances thereunto belonging, to the Grantee, its successors and assigns, to its and their own proper use and benefit forever.

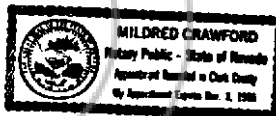
