

- 1. They are the President and Secretary respectively
  of Universal Propane Company a California corporation.
- 2. At a meeting of the Board of Directors of the corporation duly held at Sacramento, California on August 3, 1971. the following resolution was adopted:

WHEREAS, it is deemed to be to the best interests of the corporation and to the best interests of its sole shareholder that its Articles of Incorporation be amended as hereinafter provided:

NOW, THEREFORE, BE IT RESOLVED that Article One of the Articles of Incorporation of this corporation be amended to read as follows:

One: The name of this corporation is CAL GAS-LAS VEGAS, INC.

RESOLVED, FURTHER that the Board of Directors of this corporation hereby adopts and approves said amendment of its Articles of Incorporation.

- 3. The number of shares of said corporation which have consented in writing to the adoption of said amendment is five thousand (5,000) , and the wording of the amended Article as set forth in the Written Consent executed by the holder of said shares is the same as that set forth in the Directors' Resolution.
- 4. That the total number of shares entitled to vote on or consent to said amendment is five thousand.
