1 FOR VALUE RECEIVED, We promise to pay to the order of  
2 ANGE D. FREE, the sum of FORTY THOUSAND (\$40,000.00) DOLLARS,  
3 payable in monthly installments of at least THREE HUNDRED FIFTY  
4 (\$350.00) DOLLARS per month commencing May 1, 1983, each payment  
5 to include Nine (9%) per cent interest per annum on the declining  
6 balance until the balance is paid.

7 Monthly installments shall be made on or before the 1st  
8 day of each month and shall reflect payments heretofore made

10 Should any of the principal or interest not be paid when  
11 due, or within 60 days thereafter, such default shall, at the  
12 option of the legal holder hereof, cause all sums then remaining  
13 unpaid to become due upon the expiration of the grace period and  
14 payable, without further notice, the makers, endorsers, and gran-  
15 tors of this note agree to pay a reasonable collection or  
16 attorney's fee if suit is brought hereon, or said note is placed  
17 in a collector's hands, when in default, and hereby waive pre-  
18 sentment for payment notice of non-payment, protest and notice of  
19 protest, and diligence in bringing suit against any part thereto  
20 and consent that time of Payment may be extended without notice.
