PRENUPTIAL AGREEMENT

FOURTH: The party of the first part, WILLIAM E. MILLER, does hereby agree and does hereby direct that in the event of his death that the party of the second part, DONNA JEAN HIGGINS shall be permitted to reside upon and occupy for a period of Six (6) months after his death that certain real property situate in Pioche. Lincoln County, Nevada, described as follows:
