- 1. DOROTHY CUSHMAN a/k/a DOTTLE CUSHMAN, Defendant, wherein the defendant was found guilty the 8th day of June, 1983.
- That the PRINCIPAL has been convicted and is being held by the people of the State of Nevada subject to sentencing.
- 3. That defendant has been ordered to bail in the sum of \$14,000.00.

## IT IS THEREFORE, AGREED AS FOLLOWS:

- 1. The PRINCIPAL and SURETY hereby undertake that the PRINCIPAL shall appear for sentencing on said charge the 5th day of July, 1983, before this Court at Pioche, Lincoln County, Nevada. And shall at all times render herself amenable to the orders and process of the Court and the requirements of the law, and the PRINCIPAL shall appear for sentencing on the 8th day of July, 1983
- 2. If the PRINCIPAL fails to perform any of these conditions, I, the undersigned, shall pay to the people of the State of Nevada the sum of \$14,000.00.

As and for security for the feithful performance of the obligations herein incurred, the SURETY does hereby pledge to the people of the State of Nevada, in accordance with provisions of Chapter 178 of the Nevada Revised Statues, all of his right, title and interest in and to that certain piece of real property, with improvements located thereon, in the City of Caliente, County of Lincoln, State of Nevada, more particularly described as follows

Provided, however, that upon forfeiture and sale of said real property, SURETIES be remitted any surplus from the proceeds of said sale over and above the sum of \$14,000.00, interest accrued from the date of foreclosure and reasonable costs of sale.
