has located the BW- 19B lode mining claim, and by

T6S, R71E, Mount Diablo Base and Meridian.

claim filing fee has been paid.

All corners, side centers, and discovery monuments consist of 4 in.  
diameter PVC pipe 4 1/2 ft in length. Each post has been identified with  
its appropriate location in black marker pen.
