

Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 1480 feet is claimed in a N65W direction and 20 feet in a S65E direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the SE to the NW.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by blazing the tree trunk and marking number on flagging surrounding trunk.

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is tree trunk at least 4" in diameter
- Corner No. 2 is tree trunk at least 4" in diameter

- Corner No. 5 is tree trunk at least 4" in diameter
- Corner No. 6 is tree trunk at least 4" in diameter

The monumentation and marking of the corners was completed by the 28 day of May, 1983.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
