CERTIFICATE OF LOCATION OF LODE MINING CLAIM

(Prepared by the Nevada Bureau of Mines and Geology, and Approved by Attorney General of Nevada, August 1971)

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the OPHIR⁴ Lode Mining Claim in Section 17, Township 12-5, Range G.9.E in the MORMON MNT Mining District, in LINCOLN County, in the State of Nevada, on the 20th day of NOVEMBER, 1983.

The claim is 1500 feet long and 600 feet wide, and 750 feet is claimed in a WESTERLY direction and 750 feet in an EASTERLY direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the WEST to the EAST. The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by BLACK PAINT ON WHITE POST (Describe method of marking, such as "scribing the wood")

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a 4" x 5' PIPE SET IN ROCK BASE
Corner No. 2 is a 4" x 5'
Corner No. 3 is a 4" x 5'

Corner No. 6 is a 4" x 5'

The monumentation and marking of the corners was completed by the 29th day of NOVEMBER, 1983. (must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.

NRS 517.300, Subsection 2.
