The claim is 150 feet long and 60 feet wide, and 500 feet is claimed in a SOUTHERLY direction and 100 feet in a NORTHERLY direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the SOUTHERLY to the NORTHERLY DIRECTION. The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by STAMPED METAL TAG. (Describe method of marking, such as "scribing the wood")

The monumentation and marking of the corners was completed by the 16TH day of DECEMBER, 1983. (must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
