## SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

This Deed of Trust, made this 30th day of December 1983, between JOHN M. WADSWORTH and MARGARET A. WADSWORTH, Husband & Wife

Witnesseth: That Trustee IRREVOCABLY GRANTS, TRANSFERS AND ASSIGNS TO TRUSTEE IN TRUST, WITH POWER OF SALE, that Lincoln County, Nevada, described as:

That portion of the West half of the Southeast quarter of the Northeast Quarter (W $\frac{1}{2}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section 17, Township 2 South, Range 68 East, M.D.B. & M., described as follows:

Beginning at the Southwest corner of the Southeast quarter of the Northeast quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ) of said Section 17, and running thence East 633 feet along the South boundary of said SE $\frac{1}{4}$ NE $\frac{1}{4}$ ; thence North 1060 feet; thence West 633 feet to a point on the West boundary of said SE $\frac{1}{4}$ NE $\frac{1}{4}$ ; said Sec. 17, which point is 256 feet south of the Northwest corner of said SE $\frac{1}{4}$ NE $\frac{1}{4}$  Sec. 17; thence South 1064 feet along the west boundary of said SE $\frac{1}{4}$ NE $\frac{1}{4}$  Sec. 17 to the place of beginning.

TOGETHER WITH the rents, issues and profits thereof, reserving the right to collect and use the same except during continuance of some default hereunder and during continuance of such default authorizing Beneficiary to collect and enforce the same by any lawful means in the name of any party hereto.

For the Purpose of Securing: 1. Performance of each agreement of Trustor incorporated by reference or contained herein. 2. Payment of the indebtedness evidenced by one promissory note of even date herewith, and any extension or renewal thereof, in the principal sum of \$25,000.00 executed by Trustor in favor of Beneficiary or order. 3. Payment of such additional sums as may hereafter be advanced for the account of Trustor or Ansens by Beneficiary with interest thereon.

To Protect the Security of This Deed of Trust, Trustor Agrees: By the execution and delivery of this Deed of Trust and the note accrued hereby, that provisions (1) to (18) inclusive of the Deed of Trust recorded in the Book and at the page, or document No. of Official Records in the Office of the county recorder of the county where said property is located, noted below opposite the name of such county, viz.:
