As Trustor, and recorded October 28, 1981

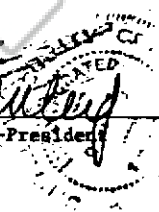

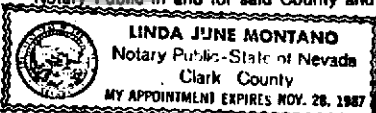
