ORDER ADMITTING DEFENDANT TO BAIL AND
ACCEPTING BAIL BOND SECURED BY PROPERTY OF SURETY

The above named defendant having been charged and arrested pursuant to the above traffic Citations is charged with being a principal to the following misdemeanors:

Citation No. A273537, a violation of NRS 482.545, Failure to Transfer Registration, \$100.00 bail, a violation of NRS 484.263, No proof of Insurance, \$200.00 bail, plus Administrative Assessment of \$20.00, a total of \$320.00 bail.

Citation No. A273538, a violation of NRS 483.560, Driving When License Suspended, \$350.00 bail, a violation of NRS 482.545, Pictitious Registration of Trailer, \$250.00 bail plus Administrative Assessment of \$20.00, a total of \$620.00 bail.
