

CERTIFICATE OF LOCATION OF MILL SITE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned hereby certifies that Argau Resources, Inc., having a post office address at Box 66, Madison, Connecticut 06443, has located the J No. 5 mill site and claims, under and by virtue of the mining laws of the United States of America and the State of Nevada, 500 feet in a Southerly direction and 531 feet in an Easterly direction from the Location Monument, at which the Notice of Location is posted, and contains 5 acres more or less.
