

CERTIFICATE OF LOCATION OF MILL SITE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned hereby certifies that Argau Resources, Inc., having a post office address at Box 66, Madison, Connecticut 06443, has located the J No. 8 mill site and claims, under and by virtue of the mining laws of the United States of America and the State of Nevada, 590 feet in a Southerly direction and 368 feet in an Easterly direction from the Location Monument, at which the Notice of Location is posted, and contains 5 acres more or less.

Said mill site is located in conjunction with the JUMBO Mine, situated in the Unknown Mining District, County of Lincoln, State of Nevada, and is more particularly described as follows:
