The claim is 1500 feet long and 600 feet wide, and 750 feet is claimed in a NORTHEASTLY direction and 750 feet in a SOUTHWESTLY direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the WEST to the EAST.

The monumentation and marking of the corners was completed by the 19 day of MAY 1984 (Must be within 90 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
