AMENDED AGREEMENT

THIS INDENTURE made this ___ day of February, 1984, between Kim Lee and Linda Lee, husband and wife, parties of the first part, and Dennis H. Adair and Jeanne M. Adair, husband and wife as joint tenants with right of survivorship, the parties of the second part, it is hereby agreed that the parties of the first part shall sell to the parties of the second part all that certain piece of land situated in the town of Panaca, County of Lincoln, State of Nevada, and bounded and described as follows:

A plot of ground, being a portion of Lot 49 in the Sungold Manor, Unit No. 1, in the said town of Panaca, Nevada, described as follows:

The southerly 40 feet of said Lot 49, being a plot of land fronting 40 feet on 6th Street of said town and extending back an equal width the full length of the lot.

It is also agreed that the purchase price of the property shall be \$3,076.80, minus the bill to Frontier Title in the amount of \$177.00, which Dennis H. Adair and Jeanne M. A plot of ground, being portions of lots 49 and 50 in the Sungold Manor, Unit No. 1, in the said town of Panaca, Nevada, described as follows:




