We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1420 feet from the location monument in an EASTERLY direction, and 20 feet in a WESTERLY direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a PVC post 4x4; 4x feet high, inscribed "NW Corner of the TARAH # 2 Claim;" the southwest corner is marked by a PVC post 4x4; 4x feet high, inscribed "SW Corner of the TARAH # 2 Claim;" the southeast corner is marked by a PVC post 4x4; 4x feet high, inscribed "SE Corner of the TARAH # 2 Claim;" the northeast corner is marked by a PVC post 4x4; 4x feet high, inscribed "NE Corner of the TARAH # 2 Claim." There is also a PVC post 4x4; 4x at the center of each side line.

The monumentation and marking of the corners was completed by the 1st day of MAY, 1984 (must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the LINCOLN County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
