

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS, That the undersigned hereby certifies that David A. Bird, having a post office address at P. O. Box 1911 - Reno, Nevada 89505, has located the IRM No. 66b lode mining claim, and claims, under and by virtue of the mining laws of the United States of America and the State of Nevada, 1,500 feet along the vein thereof, together with 300 feet on each side of the center of said vein. The general course of said vein being Southerly and Northerly with 1,490 feet claimed in a Southerly direction and 10 feet in a Northerly direction from the Discovery Monument, at which the Notice of Location is posted.
