Whereas, the Plaintiff seeks to enjoin and restrain the Defendants during the pendency of this action from the exercise of powers of sale contained in the Deed of Trust dated June 19, 1979, a copy of which is attached hereto as Exhibit "A" and incorporated berein by reference and a Deed of Trust dated february 20,71980, a copy of which is attached hereto as Exhibit "B" and incorporated herein by reference.

Whereas, Dale R. Robertson, the substituted Trustee, under both deeds of trust, has recorded "Notice of Breach and Election to Sell Under Deed of Trust\* on both deeds of trust and said

Whereas, Doyle R. Robertson has given "Trustee's Notice of Sale" dated October 23, 1984, copies of which are attached hereto and marked Exhibits "E" and "F", respectively, and incorporated herein by reference with said sale set for Monday, November 26, 1984, at 2:00 P.M., at the Lincoln County Courthouse, Pioche, Nevada.

Whereas, this Court has issued its findings of fact and conclusions of law and based upon said findings of fact and conclusions of law, and it appearing to the Court that a preliminary injunction should issue.

NOW, THEREFORE, you, the Defendants, and each of you, your officers, agents, servants, employees and attorneys are hereby absolutely enjoined and restrained during the pendency of the above entitled action and until its final determination or this Court shall otherwise order from:

- exercising any power of sale contained in the Deeds of Trust attached hereto and marked as Exhibits "A" and
- from conducting or permitting to be conducted a Trustee's sale noticed by the Trustee's Notices of Sale attached hereto as Exhibits "E" and "F" presently scheduled at 2:00 P.M., November 26, 1984, or at any other time.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Defendants shall forthwith pay over to WOOD any funds held by them or endorse to WOOD any check on which they are a payee which exists as a result of the sale of cattle from Meadow Valley Ranch.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that WOOD shall file with this Court, and with Stewart Wilson, attorney for the defendants, an accounting of any and all funds received from the sale of cattle from Meadow Valley Ranch within fifteen (15) days

1 following the receipt of said funds. Said funds shall be used 2 solely for the operation and maintenance of Meadow Valley Ranch.
