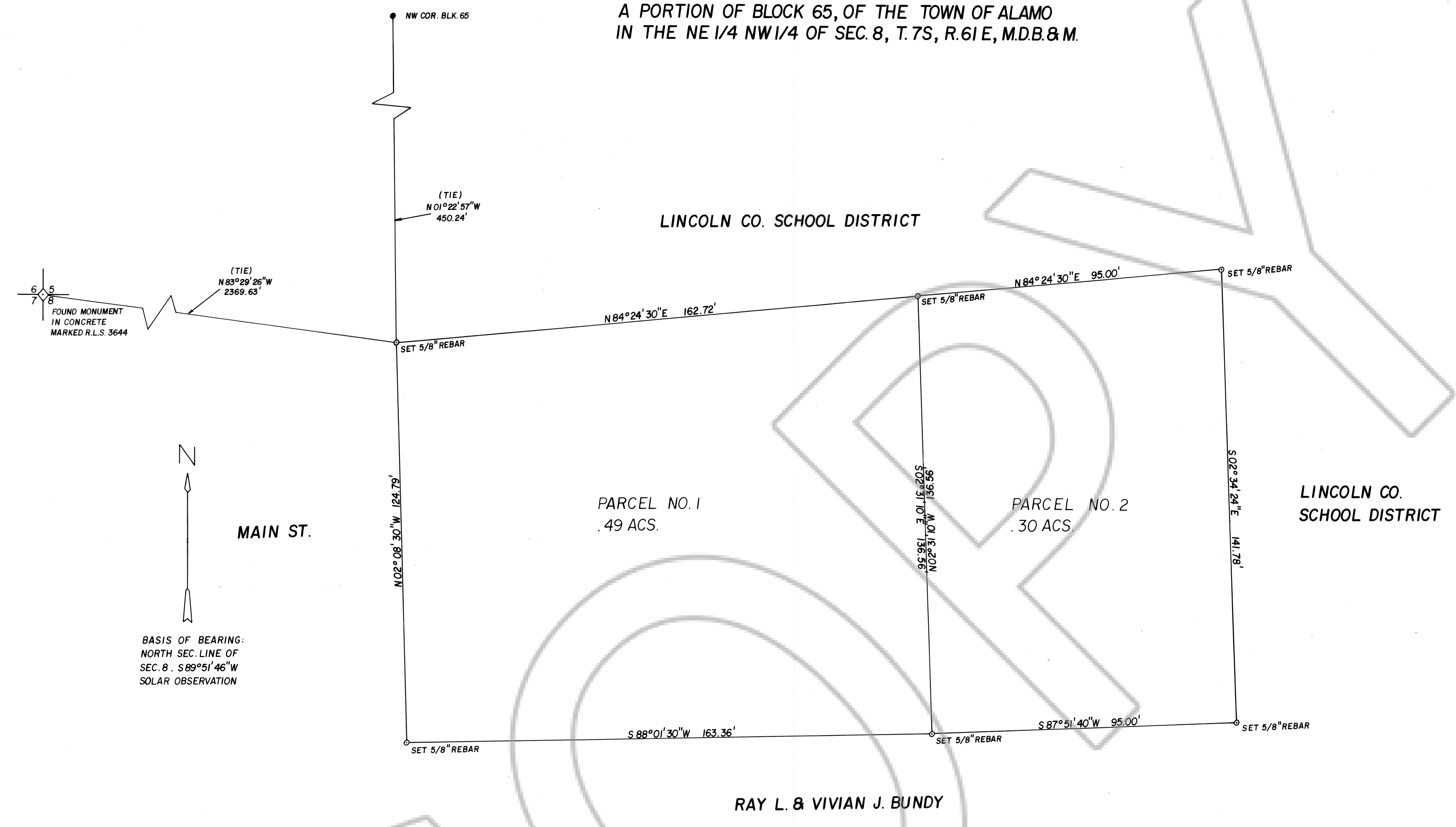


A PORTION OF BLOCK 65, OF THE TOWN OF ALAMO

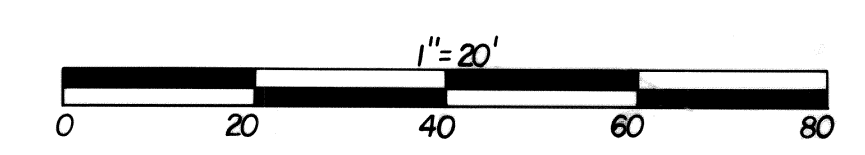
