The claim is 1500 feet long and 600 feet wide, and 1490 feet is claimed in a EAST direction and 10 feet in a WEST direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the WEST to the EAST.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by A SCRIBED ALUMINUM TAG

The monumentation and marking of the corners was completed by the 27th day of OCT., 1984.
