The claim is 1500 feet long and 600 feet wide, and 1490 feet is claimed in a WEST direction and 10 feet in a EAST direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the WEST to the EAST.

The monumentation and marking of the corners was completed by the 27th day of OCT, 1984.
