CERTIFICATE OF LOCATION
LODE MINING CLAIM

That on the 20th day of November, 1984, the above lode mining claim was duly located in the Eagle Valley Mining District, Lincoln County, Nevada.

The locator hereby claims 10 feet in a westerly direction and 1490 feet in an easterly direction from the location monument and 300 feet on each side of said lode or vein. The general course of this claim is east-west.

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The discovery monument is located approximately 800 feet in a S2°E direction from the NE corner of Section 23, Township 2 North, Range 69 East, MDB & M.

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
