CERTIFICATE OF LOCATION

The discovery monument is located approximately 2600 feet in a S1°E direction from the NE corner of Section 23, Township 2 North, Range 69 East, MDB & M.

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 4 x 4 inch wooden posts, native timber, 4 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location. Location work consisted of making the maps in accordance with NRS 517.040, which are recorded herewith.
