DECLARATION OF HOMESTEAD

1 KNOW ALL MEN BY THESE PRESENTS:

2 That I, DONALD BLANCHARD, do certify and declare as
3 follows:

4 1. That I am a married person and that my household
5 consists of myself and my wife PATRICIA BLANCHARD.

6 2. That we are now at the time of making this declaration
7 actually living on the premises described as follows:

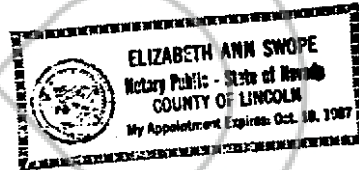
