We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1450 feet from the location monument in a northwesterly direction, and 50 feet in a southeasterly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

All claim corners, side centers and location monuments are plastic pipe or wooden posts, at least 4 inches in diameter by 5 feet in length, set 1 foot in the ground and properly marked with metal tags.

The monumentation and marking of the corners was completed by the 10th day of January, 1985.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$ 20.75 lode claim filing fee has been paid the County Recorder.
