SE/4 of Sec. 14, Twp. 8 south, Range east.
NW/4 of Sec. 14, Twp. 8 south, Range 69 east.
SW/4 of Sec. 13, Twp. 8 south, Range 64 east.

To tie this claim to the Public Survey, begin at the northeast corner of Section 25, Township 8 South, Range 68 East, Mount Diablo Meridian, thence

800' S. 73° E., 6540' N. 17° E.

to the northeast corner of this claim, corner no. 1; thence,

South 17° West, 750 feet to the East Side Center; thence,
South 17° West, 750 feet to the Southeast Corner; thence,
North 73° West, 600 feet to the Southwest Corner; thence,
North 17° East, 750 feet to the West Side Center; thence,
North 17° East, 750 feet to the Northwest Corner; thence,
South 73° East, 600 feet to the Northeast Corner; the point and place of beginning.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1450 feet from the location monument in a northeasterly direction, and 50 feet in a southwesterly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

All claim corners, side centers and location monuments are plastic pipe or wooden posts, at least 4 inches in diameter by 5 feet in length, set 1 foot in the ground and properly marked with metal tags.

The monumentation and marking of the corners was completed by the 10th day of January, 1985.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$ 20.75 lode claim filing fee has been paid the County Recorder.
